Privacy Policy FAQ's

1. Why do we need consent?

We need your consent to enable us to forward details of your enquiry onto one of our approved panel lawyers. This will enable us to appoint a suitable legal representative who will then contact you to discuss your enquiry further.

2. Who are our "approved partners"?

Whilst we cannot publish details of our panel members due to confidentiality arrangements, we can confirm that all members are all **fully regulated** by the Solicitors Regulation Authority and the appointed representative will be experienced in the field of law appropriate to the advice sought by our clients.

3. What "contact details" are we referring to?

We will collect personal information such as your name, address, contact number and other data to assist us in dealing with your request. The information that you provide to us helps us to personally identify you and is linked to dealing with your enquiry.

In addition, if we do not have the **personal contact details** the panel firm may not be able to help as they need to conduct what is called a conflict check to ensure they are legally able to advise you.

4. What do we do with the details we collect?

Once we have your data we will:

- Store your details centrally on a secure server;
- Contact you in relation to the enquiry you have made;
- With your consent, forward your information on to an approved regulated panel member to get the necessary advice and/or assistance you require.

In addition we may:

- Use the information to improve our products and services;
- We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting, using the email address which you have provided;
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interests;
